



## **Aflac U.S. 2020 EEO-1 Disclosure**

Aflac Incorporated has long maintained a strong commitment to diversity, equity and inclusion. Our view is that fostering and welcoming the full range of diversity throughout every level of our Company: among our board of directors, our management team and our employees enhances our ability to respond to our customers in the best way we can. Over the past year, we have received more inquiries from investors about seeing the actual report itself. In the spirit of transparency and responding to our investors, we are providing the EEO-1 Component 1 report on the following page. We expect to continue posting future reports in the same way after filing with the U.S. Equal Employment Opportunity Commission.

The job categories in the EEO-1 report are not reflective of Aflac's workforce or compensation system. EEO-1 job groups encompass a broad range of grade levels, job titles, technical and non-technical jobs. For reference,

- Executive/Senior Officials & Managers coordinates most closely to Aflac's definition of "executives;"
- First/Mid Officials & Managers coordinates most closely with Aflac U.S. managers and directors;
- Professionals coordinates most closely with non-managers at Aflac U.S.;
- Technicians coordinates most closely to hourly workers;
- Administrative support coordinates most closely with administrators; and
- Craft workers coordinates most closely with facilities technicians.
