

## **3M Road Safety**


#### **KEY FINDINGS**

- 1. Among the 47% of Americans planning to travel in the next 6 months, 77% plan to travel by car (personal vehicle, rental car, taxi, or rideshare) and half (51%) plan to travel for Christmas.
  - Although many are excited and happy about their upcoming travel plans, half of Americans (51%) are concerned about transportation and roadway safety when traveling outside of their community.
- 2. Top transportation/roadway safety concerns include drivers using the phone while driving (83%), driver negligence (82%), bad weather (77%), and night visibility (71%).
  - Over a third of Americans (36%) say that getting COVID-19 gives them a similar level of fear as their transportation or roadway concerns.
- 3. Americans are most concerned about safety when in a car as the passenger or as a pedestrian; there is less concern about safety on bicycles, public transportation and motorcycles, which is likely tied to lower usage of these forms of transportation. Cyclists are 45% more likely to be concerned about safety on a bicycle.
  - Over a third of Americans (35%) know someone who was seriously injured or killed in a traffic accident which causes impacts on feelings of safety; this group is 53% more likely to be concerned about safety when in a car as the passenger.
- 4. Parents are concerned about their children getting to and from school (67%), with half (48%) saying their children travel to school in a personal vehicle and 38% via school bus.
  - Concern for children is not solely among parents; 75% of Americans believe their communities should do more to make streets safe for children traveling to and from school.
- 5. Community differences exist in American perceptions of reliable and safe access to transportation in their communities. Those living in suburban areas are most likely to say they have reliable and safe access to transportation infrastructure, and those living in rural areas are least likely for all forms of transportation except roads for driving.
- 6. Most Americans believe that their communities should do more for transportation access, safety, and equity.

### Methodology

This poll was conducted between October 9, 2021 and October 13, 2021 among a sample of 2000 American adults. The interviews were conducted online and the data were weighted based on age, gender, education, region and ethnicity.

Results from the full survey have a margin of error of plus or minus 2 percentage points.

For business or leisure, are you planning to take a vacation or trip in the next 6 months?



What method(s) of transportation are you planning to use for your upcoming vacation or trip?






### American travelers are most likely to be happy and excited about their upcoming travel plans.

#### among those who are traveling in the next 6 months


How are you feeling about your upcoming travel plans?






### Despite positive feelings about upcoming travel, Americans are split on if they are concerned about safety when traveling outside their community.

How concerned are you, if at all, about transportation and roadway safety in the following transportation scenarios?




Generally, are you more concerned about transportation and roadway safety when traveling close to home or on a trip outside your community?

### Americans are less concerned about safety on bicycles, public transportation, and motorcycles, likely due to lower usage.



Of the following, when are you most concerned about transportation and roadway safety?








### Americans are most concerned about driver phone use/negligence (82%+ concerned), but bad weather and night visibility are top concerns as well (71%+).

# 36% of Americans say getting COVID-19 gives them a similar level of concern or fear as their transportation safety concerns.



### Half of Americans are most concerned about driver negligence or driver phone usage. Those aged 65+ are more likely to be most concerned about driver negligence.


Thinking about road safety, which of the following are you most concerned about? Please select up to 3.





### Visibility issues are a concern for most Americans. 78% are concerned about driving in bad weather.


Thinking specifically about visibility on roadways, how concerned are you, if at all, about the following?






### Driving in bad weather and driving at night are Americans' top visibility concerns. Those 45+ are more likely to be concerned.

### When thinking about public transportation safety, Americans are most concerned about operating in bad weather.




### Most parents report their children travel to school via personal vehicle or school bus and 67% are concerned about their children getting to and from school safely.


How do your children typically get to school? Please select all that apply.








### A third of Americans think transportation has become more dangerous during the pandemic; those 18-34, living in urban areas, and parents are more likely to think so.



Did this traffic accident occur in the past 18 months?







Accessibility and Improvements

Do you currently own or lease any of the following?




In a typical week, which of the following forms of transportation do you use?







### 40% of Americans believe transportation access is an issue in their communities. Those 18-44, parents, in urban areas, with higher income/education are more likely to believe so.

Do you believe transportation access is an issue in your community?






### Most Americans feel they have reliable and safe access to roads for driving and sidewalks; less feel they have access to public transportation and bike lanes.

Do you agree or disagree with the following statements?



# 75% of Americans believe COVID-19 has made road safety more important as more people travel by car instead of airplane or train for their vacations and trips.


